Installing the Replacement Window

- 1. Remove the eight screws securing the two end caps, and remove the end caps.
- 2. Slide the window out of the housing.
- 3. Remove the protective sleeve from the new window.



NOTE: Take care not to touch the inside surface of the window; hold it by the edges only. If necessary, clean the window using lens or window cleaner.

- 4. Slide the new window into place with the black strips facing down. Center the window on the housing.
- 5. Trim off the ends of the black strips so they are flush with the housing.
- 6. Replace the end caps and secure them with the eight screws.




Figure 1. Installing the replacement window on the light
